#### Common and simplified norms for Investor's Service Requests

It has been brought to the kind attention of the shareholders, who hold the shares of the Company in physical form that SEBI, vide Circular SEBI/HO/MIRSD/MIRSD/RTAMB/P/CIR/2021/655 dated 3<sup>rd</sup> November 2021, read with Circular dated 14<sup>th</sup> December 2021, has prescribed common and simplified norms for processing investor's service requests relating to update of PAN, KYC details, Nomination, etc. Forms for such requests in the prescribed format have been attached herewith. <u>These apply to shares held in Physical Form</u> and so such holders are requested to take note of the following:

Service Requests relating the aforesaid matters shall be made only in Form ISR1.

It shall be mandatory to provide PAN of all the holders, contact details, viz., complete postal address with pin code, mobile number and e-mail address and Bank account details viz., bank name & branch, account number and IFSC Code. These would be validated by the RTA through the mobile and e-mail address furnished.

- 1. Change in specimen signature shall be in Form ISR-2 duly attested as specified in the Form.
- 2. All eligible physical holders shall furnish Nomination in Form SH-13 or Declaration to Opt-out in Form ISR-3.
- 3. In case of changes to or cancellation of Nomination made earlier it shall be in Form SH-14.
- 4. Where nomination is cancelled but no fresh nomination is made, Declaration to Opt-out in **Form ISR-3** shall be provided.
- If the above information are not furnished, folios containing incomplete details as on 1<sup>st</sup> April 2023 would be frozen.
- 6. No service requests would be processed in respect of such frozen folios unless and until the specified information have been furnished. Also, payment of dividend would be only through electronic mode for which intimation would be furnished.
- 7. Frozen folios would be reverted to normal status by RTA only upon the prescribed information have been furnished or the entire shares under the folio dematerialized.
- 8. If such folios continue to remain frozen as on 31<sup>st</sup> December 2025, the same would be referred to concerned authorities under the provisions of Benami Transactions (Prohibition) Act, 1988/Prevention of Money Laundering Act, 2002.
- 9. In case PAN has not been linked to AADHAAR as on 31<sup>st</sup> March 2022 or extended date if any, specified by the Income Tax Authorities the related folios shall also be frozen.

10. The above changes are effective from 1<sup>st</sup> January 2022.
